

ORDINANCE NO. 2015-2135

AN ORDINANCE AMENDING SECTION 8.08.010, ENTITLED "SERVICE CHARGE," OF CHAPTER 8.08, ENTITLED "RUBBISH COLLECTION," OF TITLE 8, ENTITLED "HEALTH AND SANITATION," OF THE WESTCHESTER MUNICIPAL CODE

WHEREAS, Chapter 8.08, entitled "Rubbish Collection," of Title 8, entitled "Health and Sanitation," of the Westchester Municipal Code provides for the imposition of a fee for the collection of refuse within the Village of Westchester; and

WHEREAS, the Corporate Authorities of the Village of Westchester have determined that it is advisable, necessary and in the public interest to amend Section 8.08.010, entitled "Service charge," of Chapter 8.08, entitled "Rubbish Collection," of Title 8, entitled "Health and Sanitation," of the Westchester Municipal Code to provide for a fee for the administration of the refuse collection program in the Village of Westchester.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Westchester, Cook County, Illinois:

Section 1: Section 8.08.010, entitled "Service Charge," of Chapter 8.08, entitled "Rubbish Collection," of Title 8, entitled "Health and Sanitation," of the Westchester Municipal Code is hereby amended as follows:

8.08.10 – Service charge.

A user fee which shall be determined from time to time by the contract entered into between the Village and the residential scavenger service licensee shall be imposed for the collection of refuse, excluding recyclables. The Village shall levy on a quarterly basis fees as are set forth in the contract by and between the Village and the residential hauler, which shall be imposed on the Village water bills. In addition to the user fee, the Village shall levy an administrative fee in the amount of 5% of such user fee on all qualifying residences in the Village, except for those residences which are charged a senior customer rate. The charge shall be levied against every qualifying residence in the Village for the purpose of paying for the collection of rubbish, recycling and yard waste within the corporate limits of the Village of Westchester, as well as for paying the cost of administration of such refuse collection program.

Section 2: Any ordinance or portion of any ordinance in conflict with any provisions of this Ordinance is hereby repealed solely to the extent of such conflict.


Section 3: This Ordinance shall be in full force and effect upon its passage and approval as provided by law.


