

ORDINANCE NO. 2015 - 2130

**AN ORDINANCE AMENDING CHAPTER 11.68, ENTITLED
“HONORARY STREETS,” OF TITLE 11, ENTITLED “VEHICLES
AND TRAFFIC,” OF THE WESTCHESTER MUNICIPAL CODE
IN ORDER TO DESIGNATE "BARBARA L. BAILEY WAY"**

WHEREAS, the corporate authorities of the Village of Westchester desire to recognize Barbara J. Bailey for her service to the Village of Westchester in the capacity of Village Clerk and Village Trustee, by designating Nelson Square, from Nelson Street to Kingston Street, as “Barbara L. Bailey Way”.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Westchester, Cook County, Illinois, as follows:

Section 1. Chapter 11.68, entitled “Honorary Streets,” of Title 11, entitled “Vehicles and Traffic,” is hereby amended as follows:

Chapter 11.68 HONORARY STREETS

11. 68.010 Honorary Streets – Designated.

The following streets are designated as honorary streets:

- (a) Honorable John J. Sinde Drive, on Mayfair Avenue, from 31st Street to Canterbury Street
- (b) Honorable Angelo L. Luciano Avenue, on Sunnyside Avenue, from 31st Street to Cermak Road
- (c) Honorable Frederick Wedinger Way, on Wakefield Street, from Wolf Road to Boeger Avenue
- (d) George Zanoni Way, on Becket Avenue, from Carlisle Street to 31st Street.
- (e) Coach Gene Pingatore Way, on Sherwood Avenue, from Robinhood Street to Windsor Drive
- (f) Barbara L. Bailey Way, on Nelson Square, from Nelson Street to Kingston Street.

Section 2. The Village's Public Works Superintendent is hereby authorized and directed to install the appropriate honorary street signage for Barbara L. Bailey Way, on Nelson Square, from Nelson Street to Kingston Street.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.


