

ORDINANCE NO. 2015-2129

AN ORDINANCE AMENDING CHAPTER 2.40, ENTITLED “BOARD OF FIRE AND POLICE COMMISSIONERS,” OF TITLE 2, ENTITLED “ADMINISTRATION AND PERSONNEL,” OF THE WESTCHESTER MUNICIPAL CODE

WHEREAS, pursuant to Section 10-2.1-19 of the Illinois Municipal Code (65 ILCS 10-2.1-19) the Village of Westchester Board of Fire and Police Commissioners shall submit to the corporate authorities of the Village of Westchester (the “Village”), at a time provide by the Village, an annual report of its activities, of the rules in force and the practical effect thereof, as well as an annual budget request prior to the end of the Village’s fiscal year; and

WHEREAS, Chapter 2.40, entitled “Board of Fire and Police Commissioners,” of Title 2, entitled “Administration and Personnel,” of the Westchester Municipal Code establishes a Board of Fire and Police Commissioners for the Village of Westchester; and

WHEREAS, the corporate authorities of the Village desire to amend Chapter 2.40, entitled “Board of Fire and Police Commissioners,” of Title 2, entitled “Administration and Personnel,” of the Westchester Municipal Code, in order to require the Board of Fire and Police Commissioners to submit an annual report and budget request, by a date certain.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Westchester, Cook County, Illinois, as follows:

Section 1: The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

Section 2: Chapter 2.40, entitled “Board of Fire and Police Commissioners,” of Title 2, entitled “Administration and Personnel,” of the Westchester Municipal Code is hereby amended by adding thereto Section 2.40.070, entitled “Annual Report and Budget Request”, as follows:

2.40.070 – Annual Report and Budget Request

The Board of Fire and Police Commissioners shall submit to the corporate authorities of the Village an annual report of its activities, of the rules in force and the practical effect thereof and, a budget request for the prior fiscal year by March 31st of each calendar year.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.


