

ORDINANCE NO. 2016- 2176

**AN ORDINANCE AMENDING SECTION 11.56.030, ENTITLED “FEES”, OF CHAPTER 11.56, ENTITLED “VEHICLE LICENSES”, OF TITLE 11, ENTITLED “VEHICLES AND TRAFFIC”, OF THE WESTCHESTER MUNICIPAL CODE**

**WHEREAS**, Section 11.56.030, entitled “Fees”, of Chapter 11.56, entitled “Vehicle Licenses”, of Title 11, entitled “Vehicles and Traffic”, of the Westchester Municipal Code provides for the classification of vehicle licenses issued by the Village of Westchester (“Village”), the timeframe within which license fees are to be paid and the fees to be paid for such licenses; and

**WHEREAS**, the corporate authorities of the Village deem it in the best interest of the Village to amend the Village Code in order to increase the fees charged for vehicle licenses issued by the Village.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Westchester, Cook County, Illinois, as follows:

**Section 1.** The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

**Section 2.** Section 11.56.030, entitled “Fees”, of Chapter 11.56, entitled “Vehicle Licenses”, of Title 11, entitled “Vehicles and Traffic”, of the Westchester Municipal Code is hereby amended as follows:

**11.56.030 - Fees.**

(a) The license fee for each motor vehicle to be paid annually to the Village Clerk before April 30th of the current year shall be as follows:

<b>Motor bicycle or motor scooter, with or without side car</b>	<b>\$34.00</b>
<b>Motorcycle, with or without side car</b>	<b>\$34.00</b>
<b>Each passenger car or RV</b>	<b>\$37.00</b>

<b>Each passenger car or RV owned by an individual who has reached age sixty-five by April 30<sup>th</sup> (limited to one vehicle per owner)</b>	<b>\$21.00</b>
<b>Each resident in possession of an Illinois Antique License Plate</b>	<b>\$11.00</b>
<b>Each resident in possession of an Illinois Disabled Person License Plate on a passenger car or RV (limited to one vehicle per household)</b>	<b>\$11.00</b>
<b>Each resident with a Veterans Designation on his/her driver's license or in possession of an active military identification card (limited to one vehicle per Veterans Designation)</b>	<b>\$21.00</b>
<b>Each class 2 truck (Illinois B plate)</b>	<b>\$63.00</b>
<b>Each class 3 truck (Illinois C plate or heavier)</b>	<b>\$74.00</b>
<b>Vehicle License transfer</b>	<b>\$1.00</b>

- (b) If such license fee is paid after April 30<sup>th</sup> of the current year, the license fee to be paid shall be as follows:

<b>Motor bicycle or motor scooter, with or without side car</b>	<b>\$68.00</b>
<b>Motorcycle, with or without side car</b>	<b>\$68.00</b>
<b>Each passenger car or RV</b>	<b>\$74.00</b>
<b>Each passenger car or RV owned by an individual who has reached age sixty-five by April 30<sup>th</sup> (limited to one vehicle per owner)</b>	<b>\$42.00</b>
<b>Each resident in possession of an Illinois Antique License Plate</b>	<b>\$22.00</b>
<b>Each resident in possession of an Illinois Disabled Person License Plate on a passenger car or RV (limited to one vehicle per household)</b>	<b>\$22.00</b>
<b>Each resident with a Veterans Designation on his/her driver's license or in possession of an active military identification card (limited to one vehicle per Veterans Designation)</b>	<b>\$42.00</b>
<b>Each class 2 truck (Illinois B plate)</b>	<b>\$126.00</b>
<b>Each class 3 truck (Illinois C plate or heavier)</b>	<b>\$148.00</b>
<b>Vehicle License transfer</b>	<b>\$1.00</b>

- (c) For motor vehicles purchased after April 30<sup>th</sup>, but on or before October 31<sup>st</sup> of the current year, the license fee to be paid shall be as follows:

- (1) Where application for license is made within thirty (30) days from the date of purchase of the motor vehicle, then the license fee shall be as indicated in subsection (a) of this section.

- (2) Where application for license is made after thirty (30) days from the date of purchase of the motor vehicle, then the license fee shall be as indicated in subsection (b) of this section.
- (d) For motor vehicles purchased after October 31<sup>st</sup> of the current year, the license fee to be paid shall be one-half (1/2) of the license fee indicated in subsection (a) of this section; provided, however, that application for license is made within thirty (30) days from date of purchase of the motor vehicle; otherwise the license fee shall be as indicated in subsection (b) of this section.

**Section 3:** This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
