ORDINANCE NO. 2016-_____

**AN ORDINANCE AMENDING CHAPTER 5.36, ENTITLED “LIQUOR SALE,”
OF TITLE 5, ENTITLED “BUSINESS LICENSES AND REGULATIONS,”
OF THE WESTCHESTER MUNICIPAL CODE**

WHEREAS, Chapter 5.36, entitled “Liquor Sale”, of Title 5, entitled “Business Licenses and Regulations”, of the Westchester Municipal Code provides for the licensing and regulation of the sale of alcoholic liquor in the Village of Westchester; and

WHEREAS, the corporate authorities of the Village of Westchester have determined that it is advisable, necessary and in the public interest to amend the regulations regarding the sale of alcoholic liquor in the Village of Westchester.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Westchester, Cook County, Illinois, as follows:

Section 1: Section 5.36.010, entitled “Definitions”, of Chapter 5.36, entitled “Liquor Sale”, of Title 5, entitled “Business Licenses and Regulations”, of the Westchester Municipal Code is hereby amended by adding thereto as follows:

5.36.010 – Definitions.

Unless the context otherwise requires, the following terms as used in this Chapter shall be construed according to the definitions given below:

“Single-server containers” means any original package, as defined in this Chapter, containing 100 milliliters or less of alcoholic liquor.

Section 2: Section 5.36.090, entitled “Additional license regulations”, of Chapter 5.36, entitled “Liquor Sale”, of Title 5, entitled “Business Licenses and Regulations”, of the Westchester Municipal Code is hereby amended by adding thereto as follows:

5.36.090 – Additional license regulations.

(c) No licensee shall sell or offer for sale any alcoholic liquor in a single-server container.

Section 3: Any ordinance or portion of any ordinance in conflict with any provisions of this Ordinance is hereby repealed solely to the extent of such conflict.

Section 4: This Ordinance shall be in full force and effect upon its passage and approval as provided by law.
