**AN ORDINANCE AMENDING SECTION 2.60.140 AND 15.14.040  
OF THE WESTCHESTER MUNICIPAL CODE REGARDING BILLING FOR  
WATER AND SEWER SERVICES IN THE VILLAGE OF WESTCHESTER**

**WHEREAS**, the corporate authorities of the Village of Westchester (the "Village") deem it in the best interest of the Village to amend Paragraphs (b) and (c) of Section 2.60.140 to provide for bi-monthly billing for water services in the Village; and

**WHEREAS**, the corporate authorities of the Village deem it in the best interest of the Village to amend Paragraph (b) of Section 15.14.040 to provide for bi-monthly billing for sewer services in the Village.

**NOW, THEREFORE, BE IT ORDAINED**, by the President and Board of Trustees of the Village of Westchester, Cook County, Illinois, as follows:

**Section 1.** The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

**Section 2.** Subparagraph 3, of Paragraphs (b) and (c) of Section 2.60.140, entitled "Billing – Rates – Terms of Payment – Penalty - Water Shutoff," of Chapter 2.60, entitled "Water Department," of Title 2, entitled "Administration and Personnel," of the Westchester Municipal Code are hereby amended as follows:

- (b) Water supplied to any premises within the Village limits occupied by a Class 1 user, during any month or part thereof shall be charged and billed as follows:
  - (3) Bills to Class 1 users shall be rendered on a bi-monthly (every other month) basis, or as soon thereafter as may be practicable;
- (c) Water supplied to any premises within the Village limits occupied by a Class 2 user, during any month or part thereof shall be charged and billed as follows:
  - (3) Bills to Class 2 users shall be rendered on a bi-monthly (every other month) basis, or as soon thereafter as may be practicable;

**Section 3.** Paragraph (b) of Section 15.14.040, entitled "Rates and charges established," of Chapter 15.14, entitled "Sewers, Sewage Disposal and User Rates," of Title 15, entitled "Water and Sewers," of the Westchester Municipal Code is hereby amended by adding Subparagraph 3 thereto as follows:

- (b) Sewage disposal and user rates for any premises within the village limits occupied by any tenant, resident or owner during any month or part thereof shall be charged and billed as follows:
  - (3) Bills for sewer services shall be rendered on a bi-monthly (every other month) basis, or as soon thereafter as may be practicable.

**Section 4.** This Ordinance shall be in full force and effect upon its approval, passage and publication as provided by law.
