

ORDINANCE NO. 2018-_____

**AN ORDINANCE AUTHORIZING THE DISPOSAL OF
SURPLUS PROPERTY OWNED BY THE VILLAGE OF WESTCHESTER**

WHEREAS, pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the corporate authorities of the Village of Westchester (the “Village”) are expressly authorized to sell or otherwise dispose of personal property in such manner as they may designate with or without advertising the sale when, in the opinion of a majority of the corporate authorities then holding office, the personal property is no longer necessary or useful to the Village; and

WHEREAS, the Village owns certain personal property described in Exhibit “A” which is attached hereto and made a part hereof; and

WHEREAS, the corporate authorities of the Village expressly find that the items of personal property described in Exhibit “A” are no longer necessary to, required for use, or in the best interest of the Village to maintain, and further find that it is in the best interest of the Village to dispose of the items described in Exhibit “A”.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village Westchester, Cook County, Illinois, as follows:

Section 1: The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

Section 2. The corporate authorities of the Village of Westchester hereby authorize the Village Manager to dispose of the items of surplus property enumerated in Exhibit “A” in any manner that he deems appropriate, including, but not limited to, recycling, salvaging or scraping said property.


Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.


