## ORDINANCE NO. 2019-\_\_\_\_\_

**AN ORDINANCE AMENDING CHAPTER 11.24, ENTITLED “STOP INTERSECTIONS”, OF TITLE 11, ENTITLED “VEHICLES AND TRAFFIC”, OF THE MUNICIPAL CODE OF THE VILLAGE OF WESTCHESTER, ILLINOIS**

**WHEREAS**, the corporate authorities of the Village of Westchester (the “Village”) are expressly authorized, pursuant to Section 11-208 of the Illinois Vehicle Code (625 ILCS 5/11-208), to designate any intersection as a stop intersection requiring all vehicles to stop at one or more entrances to such intersections; and

**WHEREAS**, the Village President and Board of Trustees of the Village of Westchester have determined that it is necessary, proper and in the best interest of the Village of Westchester to amend Section 11.24.040, entitled “One-way stop intersections”, of Chapter 11.24, entitled “Stop Intersections”, of Title 11, entitled “Vehicles and Traffic”, of the Municipal Code of the Village of Westchester.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Westchester, Cook County, Illinois, as follows:

**Section 1.** The foregoing recitals are incorporated herein as the findings of the President Board of Trustees of the Village of Westchester.

**Section 2.** Section 11.24.040, entitled “One-way stop intersections,” of Chapter 24, entitled “Stop Intersections,” of Title 11, entitled, “Vehicles and Traffic,” of the Municipal Code of the Village of Westchester is hereby amended by adding Paragraph 133 thereto as follows:

133) The intersection of Thirty-first Street and Rosebrook Circle in the Village of Westchester, Cook County, Illinois, is designated as a one-way stop intersection and the proper stop sign shall be installed at the corner of said intersection directing southbound vehicles on Rosebrook Circle to stop in the manner prescribed by law.

**Section 3.** This Ordinance shall be in full force and effect upon its passage, approval and publication in the manner provided by law.
