AN ORDINANCE WAIVING COMPETITIVE BIDDING AND AUTHORIZING THE ACCEPTANCE OF A PROPOSAL FROM LYONS & PINNER ELECTRIC COMPANIES, INC. FOR THE SUPPLY AND INSTALLATION OF STREET LIGHT POLES

WHEREAS, the corporate authorities of the Village of Westchester (the "Village") may, by a vote of two-thirds of the trustees then holding office, waive the requirement of the Village of Westchester Purchasing Policies and Procedures Manual to publicly advertise and solicit competitive bids for a purchase of goods or services in the amount of twenty thousand dollars (\$20,000.00) or more; and

WHEREAS, the corporate authorities of the Village find it advisable, necessary and in the best interest of the public to accept a proposal from Lyons & Pinner Electric Companies, Inc. for the supply and installation of certain street light poles within the Village (the "Proposal").

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Westchester, Cook County, Illinois, as follows:

Section 1. The corporate authorities of the Village of Westchester hereby waive the competitive bidding requirements of the Village of Westchester Purchasing Policies and Procedures Manual.

Section 2. The corporate authorities of the Village of Westchester hereby accept the Proposal from Lyon & Pinner Electric Companies, Inc. and hereby authorize and direct the Village Manager to execute the Proposal on behalf of the Village, a copy of which is attached hereto as Exhibit "A" and made a part hereof.

Section 3. This Ordinance shall be in full force and effect upon its passage, as provided by law.

- Supply and install a new aluminum street light pole and arm.
- Supply and install a new led light fixture.
- Wire and test.

Total cost: 3,950.00

2. 2112 Hull

- Break down concrete foundation and repair damaged anchor bolts. Frame and pour new foundation cap and install break a way base.
- Supply and install a new aluminum street light pole and arm.
- Supply and install a new led light fixture.
- Wire and test.

Total cost: \$6,595.00

3 Cermak East of Westchester Blvd

- Break down concrete foundation and repair damaged anchor bolts. Frame and pour new foundation cap and install break a way base.
- Supply and install a new aluminum street light pole and arm.
- Supply and install a new led light fixture.
- Wire and test.

Total cost: \$6,975.00

4. 9834 Roosevelt Rd

- Straighten anchor bolts and install break a way base.
- Supply and install a new aluminum street light pole and arm.
- Supply and install a new led light fixture.
- Wire and test.

Total cost: \$4,350.00

5. 10020 Roosevelt Rd

- Straighten anchor bolts and install break a way base.
- Supply and install a new aluminum street light pole and arm.
- Supply and install a new led light fixture.
- Wire and test.

Total cost: \$4,350.00

6. 9929 Roosevelt Rd Norfolk side

- Straighten anchor bolts and install break a way base.
- Supply and install a new aluminum street light pole and arm.
- Supply and install a new led light fixture.
- Wire and test.

Total cost: \$3,895.00

7. Across from 2255 Enterprise Dr.

- Break down concrete foundation and repair damaged anchor bolts. Frame and pour new foundation cap and install break a way base.
- Supply and install a new concrete street light pole and arm.
- Supply and install a new led light fixture.
- Wire and test.

- Total cost: \$6,975.00

8. Mannheim Road pole

- Supply and install a new concrete street light pole and arm.
- Supply and install a new led street light fixture
- Wire and test.

Total cost per location: \$7,980.00

Excluded in above cost:

- Any cable replacement.
- Permit fee.
- Restoration of any type.
- Any work not listed in scope.

Poles that need to be taken down and disposed of on Mannheim Road will be done on a time and material basis.

All pole will have an eight to ten week lead time from date ordered.
