

ORDINANCE NO. 2020-_____

**AN ORDINANCE AMENDING THE
ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING MAY 1, 2019
AND ENDING APRIL 30, 2020 IN THE VILLAGE OF WESTCHESTER**

WHEREAS, the annual budget for the fiscal year beginning May 1, 2019 and ending April 30, 2020 was approved by the President and Board of Trustees on April 23, 2019; and

WHEREAS, Section 8-2-9.6 of the Illinois Municipal Code (65 ILCS 5/8-2-9.6) provides that the Village of Westchester, by a vote of two-thirds (2/3) of the members of the corporate authorities then holding office, may revise the annual budget by deleting, adding to, changing or creating sub-classes within object classes and object classes themselves.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Westchester, Cook County, Illinois, as follows:

Section 1. The annual budget for the fiscal year beginning May 1, 2019 and ending April 30, 2020 is hereby amended, as follows:
