**AN ORDINANCE WAIVING COMPETITIVE BIDDING AND AUTHORIZING THE
EXECUTION OF A CONTRACT AMENDMENT BETWEEN
SINNOTT TREE SERVICE, INC. AND THE VILLAGE OF WESTCHESTER**

WHEREAS, the corporate authorities of the Village of Westchester (the “Village”) may, by a vote of two-thirds of the trustees then holding office, waive the requirement of the Village of Westchester Purchasing Policies and Procedures Manual to publicly advertise and solicit competitive bids for a purchase of twenty thousand dollars (\$20,000.00) or more; and

WHEREAS, the corporate authorities of the Village find that it is advisable, necessary and in the public interest that the Village contract for tree trimming, tree removal and emergency tree work through the Tree Maintenance Program (the “Program”); and

WHEREAS, the Village entered into the a contract with Sinnott Tree Service, Inc. on June 25, 2019 to provide the services required for the Program, which contract expired on April 30, 2020; and

WHEREAS, the corporate authorities of the Village find it advisable, necessary and in the best interest of the public to amend the contract with Sinnott Tree Service, Inc. for the services required by the Program (the “ Contract Amendment”).

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Westchester, Cook County, Illinois, as follows:

Section 1. The corporate authorities of the Village of Westchester hereby waive the competitive bidding requirements of the Village of Westchester Purchasing Policies and Procedures Manual.

Section 2. The corporate authorities of the Village of Westchester hereby approve the Contract Amendment, a copy of which is attached hereto as Exhibit “A” and made a part hereof,


and hereby authorize and direct the Village President to execute, the Contract Amendment, on behalf of the Village of Westchester.
