Incident was worked thoroughly with joint effort of Investigations and Patrol Division throughout the day. Jaylin Price, 18, Westchester was taken into custody by Police. Cook County States Attorney Office was contacted and Price was charged with two Felonies. Attempted First Degree Murder and Aggravated Battery/Discharge of Firearm.
